

Dividends Payment

São Paulo, April 27, 2018 - EZ TEC Empreendimentos e Participações S.A. (“Company” or “EZTEC”) (**B3: EZTC3; Bloomberg EZTC3:BZ**), informs its shareholders that, in the Annual Shareholders’ Meeting held on this date, at 10am, it was approved the payment of dividends of the year of 2017 in the amount of eighty-five million, two hundred and twenty-one thousand, six hundred and seventy-nine reais and fourteen cents (R\$ 85,221,679.14), equivalent to R\$ 0.516489444 per ordinary share.

The dividends will be paid to the shareholders until November 30, 2018, at the discretion of the Company’s management, based on the stock position of April 27, 2018 and the total amount of shares entitled to dividends held by shareholders on such date, and as of April 30, 2018 (inclusive) the shares of the Company will be traded ex-dividends. Dividends shall be paid without any indexation and withholding income tax, in the terms set forth in article 10, of Law No. 9.249/95.

The shareholders will have their credits available according to the banking address provided to Itaú Unibanco S.A., the depository institution for the Company’s shares, as of the payment date set forth above.

In the case of shareholders whose shares are held in the stock exchange market, it will be paid through their custody agents (Stock Brokers).

For those shareholders whose registration does not contain their corporate or individual taxpayer’s numbers (CNPJ/MF or CPF/MF, respectively), or the indication of their “Bank/Branch/Bank Account”, the dividends will only be credited after the third business day, counted as of the date of the registration’s update in the electronic files of Itaú Unibanco S.A., which may be carried out in any branch of the chain or specialized branch indicated below. 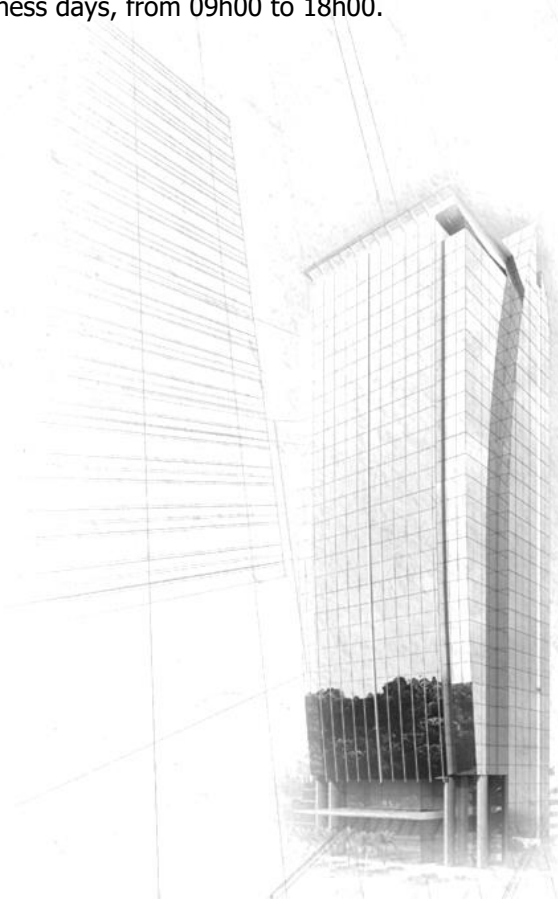
